### Total XUMCoin Supply

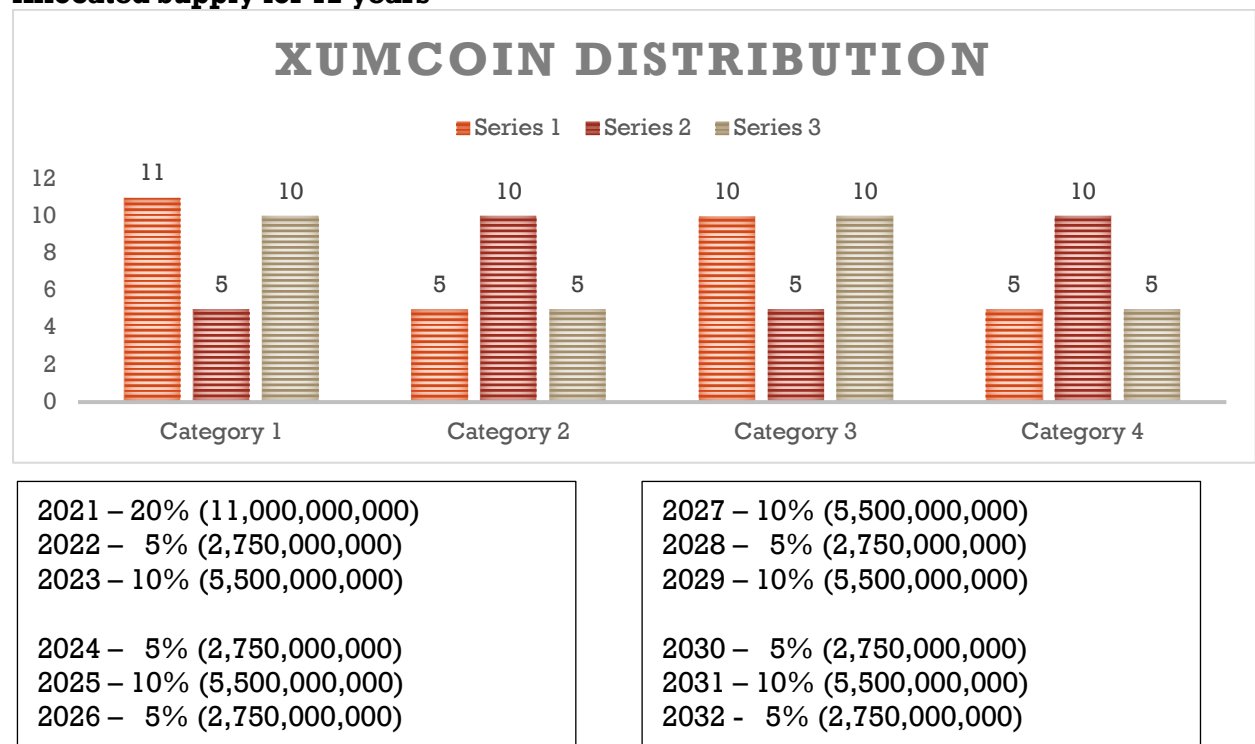
The total pre-mined supply of XUMCoin is 55,000,000,000 coins.
